- **Status:** Progress of specific cases monitored for developments (e.g. withdrawal, grant, opposition).

- Variety of techniques employed (CDROM, Internet, On-line, Manual) to suit the circumstances.
- Work undertaken by subject specialists and/or linguists as appropriate.
- Strict quality system (ISO 9001).
- Profiles “tuned” to your specific requirements. Designed to minimise “noise”.

- Includes a list of cases located and details of periods covered.
